Approval of Meeting Minutes:

Treasurer's Report -

- 1. Treasurer, L Marotta reported that our Operating Account Balance as of June 30, 2025 was \$26642.11 and Reserve Account Balance was \$96191.37.
- 2. Delinquencies are down. L DeSantis to deposit the Foreclosure Settlement payment of \$6869.09 to the operating account tomorrow. A couple of delinquencies were sent to the attorney to begin the lien process.
- Budget Committee L Marotta asked for volunteers to be on the committee to begin planning the 2026 budget. Volunteers: L DeSantis, R Santangelo, L Marotta, M D'Elia, P Belcher (resident), and R Sloop (resident)

Property Manager's Report – Property Manager, L DeSantis, sent the Board a Manager's Report prior to the meeting.

- 1. Violations Four violations were referred to the Fining Committee for review.
- 2. Leasing No changes from last report.
- 3. Irrigation MSI will be coming out in 7-10 days to check on the repairs previously made. Discussion regarding evaluating the current system to determine if we should keep repairing it or begin the process of obtaining bids for a new system. L DeSantis to contact MSI and additional companies to evaluate our current system.
- 4. Landscaping
 - There are two trees that are distressed at the front of the property both have been evaluated and are not able to be saved. Bid of \$1200 to remove each tree. L Marotta moved to approve, 2nd by T Reynoso. Passed.
 - The 5 palms at the Patricia St entrance were trimmed recently
 - The sod installed as part of the creek erosion repair project is growing in well
- 5. ARC Requests
 - 155 Devon Ct M D'Elia moved to approve, 2nd by T Reynoso. Passed.
 - 1138 Somerset Circle S T Reynoso moved to approve, 2nd by M D'Elia. Passed.

 - Fence repairs behind the tennis court (6 posts in concrete), 153 Devon (4 posts in concrete)
